## Paperless Billing Option

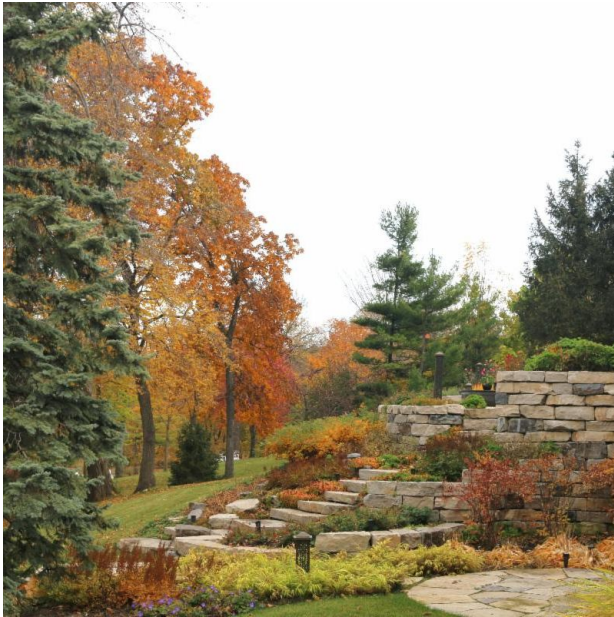
