Watering Guidelines



The Chicagoland area has not received much rain lately, and there is not much in the forecast, so we want to remind homeowners of the recommended watering guidelines to ensure plants receive enough moisture to retain their good health.

Annuals & Perennials: 1-2 hours twice per week. Let top of soil dry without plant wilting.

Established Groundcover: 1 hour every 2 weeks.

Small Shrubs: Soaker hose or slow trickle 1-2 hours per week.

Ornamental Trees & Large Evergreens: Soaker hose or slow trickle 4 hours per week.

Lawns: Give new sod a good soaking 45-60 minutes daily. Sprinkle seed daily just enough to keep it moist. Established lawns need 1-1.5" of water per week, depending on such exposure, or you can let it go dormant. <u>Please note:</u> new sod should be watered in the morning or late afternoon. Avoid watering sod in the evening as a wet lawn can invite overnight pests, disease and/or fungus, which can lead to dead grass.

Those with irrigation systems should have them adjusted accordingly during dry spells or in the height of summer heat. We encourage saving these guidelines for reference throughout the growing season.
